

#### Conclusion





# CHAMS Association







PKF Jordan & Iraq signed an engagement letter to provide external audit services of project 42 Amman for CHAMS Association.

The audit is conducted in accordance with ISA 805 (Revised), "Special Considerations—Audits of Single Financial Statements and Specific Elements, Accounts, or Items of a Financial Statement." The main objectives of the compliance audit are:

- To assess the company's adherence to regulatory requirements.
- To evaluate the effectiveness of internal controls and processes.
- · To identify areas of non-compliance.

The objective of the final evaluation is to assess the impact of FSPI within the 42 Amman program on the beneficiaries. In addition, the aim is to determine beneficiaries' experiences and perceptions of the project's effectiveness, document successes, challenges, and lessons learned, and develop recommendations for the future.

42 Amman is a program by the Crown Prince Foundation, led in partnership with the CHAMS Association, CHAMS la Française de l'éducation, a strategic partnership of the Ministry of Planning and International Cooperation of Jordan, the French Embassy in Jordan, and implemented by the College of Advanced Vocational Training of Jordan (formerly HTUPlus).

42 Amman is a unique, disruptive, and future-proof computer science training program that aims to educate Jordan's next generation of coders. 42 Amman is based upon the game-changing Ecole 42 method, centered around a teacherless coding approach with curricula designed to enable a career as a software engineer and coder over 18 months. Approximately 50,000 students have graduated from 54 partner schools globally and are widely recognized among the best creative ICT talents in the world, with an employment rate close to 100%.



### **Medical Aid for Palestinians**

PKF Jordan & Iraq has signed an engagement letter with Medical Aid for Palestinians to conduct a Capacity Needs Assessment (CNA) and develop a Capacity Building Plan (CBP).
